Getting Ready for Class

- Skaters will need all forms completed and turned in prior to the first Club Ice. No same day registration!
- Skaters will be allowed in the ice center **10 minutes ahead** of their class time. No spectators/parents are allowed in the ice rink.
- **SKATERS NEED TO COME READY TO SKATE. PARENTS NEED TO WAIT OUTSIDE.**
- Skaters will need to wear a mask. Bandanas or neck gaiters may not be worn by skaters or volunteers. Skaters must have gloves or mittens.
- Skaters will need to leave 5 minutes after their ice time is over.

2020-2021 COVID Rink Guidelines until further notice

- All skaters/legal guardian (if skater is under the age of 18) need to complete a waiver before entering the building.
- Face masks are required at all times. No bandanas or neck gaiters are allowed.
- No spectators or parents in the facility.
 - Only the skaters, coaches and approved volunteers should enter the facility. At this time we ask that all parents wait outside of the facility.
- All skaters/coaches need to enter the main ice center door, no entrance by anyone by any other door.
 - The doors will be clearly marked for designated entry and exit.
- There will be hand sanitizer just inside the front doors.
 - All participants and coaches should use it upon entering the rink.
- Skaters may enter the rink 10 minutes before class/ice time.
- Skaters/coaches should arrive ready to go on the ice. There will be chairs in the lobby that will be 6 feet apart. Please do not move the chairs.
- Skaters are encouraged to have their own skates. If a skater needs help with putting on skates a parent may come to a designated area, put skates on and then must leave the building.
- Skaters/coaches will have 5 minutes to leave the building once their ice time is done.
 - Skaters must be picked up on time.
- There is no public skate sessions
- There will be no concessions.
- Locker Rooms will be closed until further notice.
- Water fountain and bottle filler are closed.
 - Skaters will need to bring their own, labeled and may not share water bottles.
- Upstairs viewing area and conference room are closed.
- Restrooms should only be used for urgent use.
- Skaters are not allowed to loiter or explore other parts of the rink.
- Cleaning will happen during the transition times.
- **Skaters/coaches that do not feel well or are sick must stay home.**
- **If a skater has direct contact to a positive COVID person or have COVID, they must call Chris Pawlowski 920-973-6756. A skater/family must quarantine for 14 days or longer if a family member has it in the same household.**

**ASSUMPTION OF RISK, WAIVER AND RELEASE, AND
INDEMNIFICATION AGREEMENT**

In consideration of the opportunity to participate in Learn to Skate USA/MCFSC sanctioned events and activities during the 2020-21 season ("Events and Activities"), the undersigned, individually, and on behalf of his/her heirs, personal representatives, administrators, agents, successors and assigns (collectively referred to herein as "Participant"), AGREES TO ASSUME THE RISK AND RESPONSIBILITY, TO RELEASE AND TO INDEMNIFY MCFSC, Learn to Skate USA and U.S. Figure Skating, their directors, officers, members, employees, officials, committees, volunteers, clubs, affiliates, sponsors, representatives, agents, successors and assigns, including the host club, local organizing committee and any other entity responsible for the hosting, sponsoring, sanctioning and/or conduct of the Events and Activities (collectively referred to herein as "Learn to Skate USA/MCFSC"), as follows:

1. Assumption of Risk and Responsibility. Participant fully understands and appreciates the risks of injury that may occur in ice skating or in the course of preparing for, participating in and traveling to or from the Events and Activities. The risks of injury that may occur include, but are not limited to, the risk of, serious bodily injury, viral infections, bacterial infections and risk of other communicable diseases and illness, permanent disability, paralysis and death (collectively referred to herein as "Risks"). Participant acknowledges that Participant voluntarily engages in such Events and Activities with adequate knowledge of such Risks; and agrees that Participant fully assumes all such Risks and all legal and financial responsibility for (a) any and all injuries or damages, whether to person or property, that Participant may in any manner sustain in connection therewith or in the conduct and management of the Events and Activities, including such injury or damage that may result from the negligence of Learn to Skate USA/MCFSC or from some other cause and (b) all treatment, hospitalization and other care rendered to Participant in the event of Participant's illness, injury or other emergency circumstance in connection with participation in the Events and Activities, subject to any applicable insurance coverage.

2. Release and Indemnification. Participant hereby fully and forever releases, discharges, holds harmless, and agrees to indemnify Learn to Skate USA/MCFSC from and against any and all liabilities, claims, demands, lawsuits, damages, and judgments, present or future, known or unknown, valid or invalid, direct or consequential, together with reasonable costs and attorneys' fees, which result directly or indirectly from damages, losses, injuries or death to Participant, Participant's property, other persons or property incurred during or in connection with any activities associated with or being a part of the Events and Activities and the conduct and management thereof, including any participation, travel or medical treatment, hospitalization or other care rendered in connection with the Events and Activities, whether such loss, damage, injury or death results from the negligence of Learn to Skate USA/MCFSC or from some other cause.

I HAVE READ THIS ASSUMPTION OF RISK, WAIVER AND RELEASE, AND INDEMNIFICATION AGREEMENT, FULLY UNDERSTAND ITS TERMS, UNDERSTAND THAT I AND THE MINOR HAVE GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING IT AND HAVE SIGNED IT FREELY AND WITHOUT ANY INDUCEMENT OR ASSURANCE OF ANY NATURE. I INTEND IT TO BE A COMPLETE AND UNCONDITIONAL RELEASE OF ALL LIABILITY TO THE GREATEST EXTENT ALLOWED BY LAW AND AGREE THAT IF ANY PORTION OF THIS AGREEMENT IS HELD TO BE INVALID THAT THE REMAINING PROVISIONS SHALL CONTINUE IN FULL FORCE AND EFFECT.

Voluntary Waiver and Release of Liability - Covid-19

I understand that the risk of becoming exposed to or infected by COVID-19 at and any MCFSC skating activity, meeting or gathering at the Manitowoc County Ice Center may result from the actions, omissions, or negligence of myself and others, including, but not limited to, MCFSC and its volunteers, instructors, program participants and their families. I voluntarily agree to assume all of the foregoing risks and accept sole responsibility for any injury to my child(ren) or myself (including, but not limited to, personal injury, disability, and death), illness, damage, loss, claim, liability, or expense, of any kind, that I or my child(ren) may experience or incur in connection with my child(ren)'s attendance at the Manitowoc County Ice Center or participation in MCFSC programming ("Claims"). On my behalf, and on behalf of my child(ren), I hereby release, covenant not to sue, discharge, and hold harmless MCFSC, its volunteers, instructors, agents and representatives, of and from all Claims, including all liabilities, claims, actions, damages, costs or expenses of any kind arising out of or relating thereto. I understand and agree that this release includes any Claims based on the actions, omissions, or negligence of MCFSC, its volunteers, instructors, agents and representatives, whether a COVID-19 infection occurs before, during, or after participation in any MCFSC programming at the Manitowoc County Ice Center.
