**2021-2022 ASSUMPTION OF RISK, WAIVER AND RELEASE, AND
INDEMNIFICATION AGREEMENT**

In consideration of the opportunity to participate in Learn to Skate USA/MCFSC sanctioned events and activities during the 2021-2022 season ("Events and Activities"), the undersigned, individually, and on behalf of his/her heirs, personal representatives, administrators, agents, successors and assigns (collectively referred to herein as "Participant"), AGREES TO ASSUME THE RISK AND RESPONSIBILITY, TO RELEASE AND TO INDEMNIFY MCFSC, Learn to Skate USA and U.S. Figure Skating, their directors, officers, members, employees, officials, committees, volunteers, clubs, affiliates, sponsors, representatives, agents, successors and assigns, including the host club, local organizing committee and any other entity responsible for the hosting, sponsoring, sanctioning and/or conduct of the Events and Activities (collectively referred to herein as "Learn to Skate USA/MCFSC"), as follows:

1. Assumption of Risk and Responsibility. Participant fully understands and appreciates the risks of injury that may occur in ice skating or in the course of preparing for, participating in and traveling to or from the Events and Activities. The risks of injury that may occur include, but are not limited to, the risk of, serious bodily injury, viral infections, bacterial infections and risk of other communicable diseases and illness, permanent disability, paralysis and death (collectively referred to herein as "Risks"). Participant acknowledges that Participant voluntarily engages in such Events and Activities with adequate knowledge of such Risks; and agrees that Participant fully assumes all such Risks and all legal and financial responsibility for (a) any and all injuries or damages, whether to person or property, that Participant may in any manner sustain in connection therewith or in the conduct and management of the Events and Activities, including such injury or damage that may result from the negligence of Learn to Skate USA/MCFSC or from some other cause and (b) all treatment, hospitalization and other care rendered to Participant in the event of Participant's illness, injury or other emergency circumstance in connection with participation in the Events and Activities, subject to any applicable insurance coverage.

2. Release and Indemnification. Participant hereby fully and forever releases, discharges, holds harmless, and agrees to indemnify Learn to Skate USA/MCFSC from and against any and all liabilities, claims, demands, lawsuits, damages, and judgments, present or future, known or unknown, valid or invalid, direct or consequential, together with reasonable costs and attorneys' fees, which result directly or indirectly from damages, losses, injuries or death to Participant, Participant's property, other persons or property incurred during or in connection with any activities associated with or being a part of the Events and Activities and the conduct and management thereof, including any participation, travel or medical treatment, hospitalization or other care rendered in connection with the Events and Activities, whether such loss, damage, injury or death results from the negligence of Learn to Skate USA/MCFSC or from some other cause.

I HAVE READ THIS ASSUMPTION OF RISK, WAIVER AND RELEASE, AND INDEMNIFICATION AGREEMENT, FULLY UNDERSTAND ITS TERMS, UNDERSTAND THAT I AND THE MINOR HAVE GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING IT AND HAVE SIGNED IT FREELY AND WITHOUT ANY INDUCEMENT OR ASSURANCE OF ANY NATURE. I INTEND IT TO BE A COMPLETE AND UNCONDITIONAL RELEASE OF ALL LIABILITY TO THE GREATEST EXTENT ALLOWED BY LAW AND AGREE THAT IF ANY PORTION OF THIS AGREEMENT IS HELD TO BE INVALID THAT THE REMAINING PROVISIONS SHALL CONTINUE IN FULL FORCE AND EFFECT.

2021-2022 Voluntary Waiver and Release of Liability - Covid-19

Relying upon the guidelines provided by the United States Figure Skating Association, the United States Rinks Association, the State of Wisconsin, Manitowoc County and City of Manitowoc, the Manitowoc County Figure Skating Club, "MCFSC", I the undersigned on my own behalf and on behalf of my minor child or children as listed here

_____ expressly understand that MCFSC has put in place enhanced health and safety measures to reduce the spread of COVID-19. I also understand that MCFSC cannot guarantee that I or my child(ren) will not become infected with COVID-19. By signing this agreement and visiting and using the facilities of MCFSC, specifically the Manitowoc County Ice Center, I acknowledge that an inherent risk of exposure to COVID-19 exists in any public place where people are present. I further acknowledge the contagious nature of COVID-19 and voluntarily assume the risk that my child(ren) and I may be exposed to or infected by COVID-19 by participating in skating activities presented by MCFSC at the Manitowoc County Ice Center. I further understand and expressly acknowledge on my own behalf and on behalf of my child(ren) that by participating in skating activities of MCFSC and/or being present at the Manitowoc County Ice Center for any reason, that such exposure to Covid-19 or infection of Covid-19 may occur and result in extreme illness, permanent disability, and possibly death. I understand that the risk of becoming exposed to or infected by COVID-19 at and any MCFSC skating activity, meeting or gathering at the Manitowoc County Ice Center may result from the actions, omissions, or negligence of myself and others, including, but not limited to, MCFSC and its volunteers, instructors, program participants and their families. I voluntarily agree to assume all of the foregoing risks and accept sole responsibility for any injury to my child(ren) or myself (including, but not limited to, personal injury, disability, and death), illness, damage, loss, claim, liability, or expense, of any kind, that I or my child(ren) may experience or incur in connection with my child(ren)'s attendance at the Manitowoc County Ice Center or participation in MCFSC programming ("Claims"). On my behalf, and on behalf of my child(ren), I hereby release, covenant not to sue, discharge, and hold harmless MCFSC, its volunteers, instructors, agents and representatives, of and from all Claims, including all liabilities, claims, actions, damages, costs or expenses of any kind arising out of or relating thereto. I understand and agree that this release includes any Claims based on the actions, omissions, or negligence of MCFSC, its volunteers, instructors, agents and representatives, whether a COVID-19 infection occurs before, during, or after participation in any MCFSC programming at the Manitowoc County Ice Center.
